List of Narcotic and Psychotropic Drugs Prohibited for Entry

1. Core regulatory basis and catalogue system

In accordance with laws and regulations such as the *Drug Administration Law of the People's Republic of China*, the Regulation on the Administration of Narcotic Drugs and Psychotropic Drugs, and the List of the People's Republic of China of Articles Prohibited from Import and Export, a control system featuring "three major catalogues + dynamic adjustments" has been established, specifically including:

- 1.1 The List of Narcotic Drugs for Medical Use (2025 Edition) (123 varieties, including newly added ones)
- 1.2 The List of Psychotropic Substances for Medical Use (2025 Edition) (151 varieties, divided into Class I and Class II) (For the above two lists, please refer to the "Link 1" in Appendix)
- 1.3 The Supplementary List of Controlled Non-pharmaceutical Narcotic Drugs and Psychotropic Substances (including the entire class of Synthetic Cannabinoids and 18 specific substances) (For details, please refer to the "Link 2" in Appendix)

All varieties listed in the aforementioned lists, except for those exempted by law, fall under the category of prohibited unauthorised entry, and the customs shall exercise supervision in accordance with the law.

- 2. Categorised list of key varieties prohibited for entry
 - 2.1 Core varieties of narcotic drugs

Classical controlled varieties: Opium, Morphine, Heroin, Marijuana (HS code: 1211903930), Thebaine, and other traditional drug-producing plants and their products

Synthetic varieties: Fentanyl, Alfentanil, Remifentanil, Sufentanil, Methadone, Metamfetamine, etc.

Newly added controlled varieties: Tegileridine, Oliceridine, and other varieties in the 2025 Supplementary List

2.2 Core varieties of psychotropic substances

Class I (Strictly prohibited from unauthorised entry)

Central nervous system stimulants: Methylphenidate, Dexamfetamine, Levamfetamine, Mazindol, etc.

Hallucinogenic and dependence-producing substances: Ketamine, Gamma-hydroxybutyrate, Amphetamine derivatives, etc.

Case-related varieties: Methylphenidate tablets seized by Kunming Customs fall into this category

Class II (Restricted entry and special permission required)

Sedatives and hypnotics: Diazepam, Estazolam, Alprazolam, Lorazepam, Clonazepam, etc.

Analgesics: Tramadol, Dezocine, Butorphanol, etc.

Other varieties: Dextromethorphan, Etomidate (excluding medicinal preparations), F-Ketamine, etc.

2.3 Non-pharmaceutical controlled varieties

Entire class controlled: Synthetic Cannabinoids

Specific varieties: 18 substances, including F-Ketamine, which are prohibited from being imported and exported by any units or individuals without authorisation

- 3. Exemptions and approval requirements for entry
 - 3.1 Medicines for personal use

An individual may carry narcotic drugs and Class I psychotropic substances within the maximum dosage specified in a single prescription for the treatment of a disease, and shall provide the following materials:

- 3.1.1 Medical diagnosis certificate issued by a medical institution
 - 3.1.2 Personal identity document
- 3.1.3 Customs clearance is granted based on the principle of reasonable self-use, and the prescribed dosage for Class II psychotropic substances may be appropriately extended

3.2 Medicines for teams

For medicines used by team members, the Chief Medical Officer of each NOC delegation shall sign the NOC Declaration for the Import of Narcotic Drugs and Psychotropic Drugs and the NOC Declaration for the Import of Non-Narcotic Drugs and

Non-Psychotropic Drugs, and send them to the SABGOC's email address in accordance with the Healthcare Guide: medical@sanya2026.cn

The application for the import of non-narcotic and non-psychotropic medications shall not contain any medications prohibited for entry.
